**Restriction against Sex Offenders Employed by service providers to
Government of Guam from working on Government Property.**

If a contract for services is awarded to the bidder or offeror, then the service provider must warranty that no person in its employment who has been convicted of a sex offense under the provisions of chapter 25 of Title 9 of Guam code Annotated or of an offense defined in Article 2 of chapter 28 of Title 9 of the Guam Code annotated, or who has been convicted in any other jurisdiction of an offense with the same elements as heretofore defined, or who is listed on the Sex Offender Registry, shall provide services on behalf of the service provider while on government of Guam property, with the exception of public highways. If any employee of a service provider is providing services on government property and is convicted subsequent to an award of a contract, then the service provider warrants that it will notify the Government of the conviction within twenty-four (24) hours of the conviction, and will immediately remove such convicted person from providing services on government property. If the service provider is found to be in violation of any of the provisions of this paragraph, then the government will give notice to the service provider to take corrective action. The service provider shall take corrective action within twenty-four (24) hours of notice from the Government, and the service provider shall notify the Government when action has been taken. If the service providers fail to take corrective steps within twenty-four (24) hours of notice from the Government, then the Government in its sole discretion may suspend temporarily and contract for services until corrective action has been taken.

Should any contract contain a renewal clause, then at the time of renewal adjustments, there shall be made stipulations contained in that contract for applying the Wage Determination, as required by this Article, so that the Wage Determination promulgated by the U.S. Department of Labor on a date most recent to the renewal date shall apply.

§ 5802. Benefits.

In addition to the Wage Determination detailed in this Article, any contract to which this Article applies shall also contain provisions mandating health and similar benefits for employees covered by this Article, such benefits having a minimum value as detailed in the Wage Determination issued and promulgated by the U.S. Department of Labor, and shall contain provisions guaranteeing a minimum of ten (10) paid holidays per annum per employee.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

**** UNIFORM ALLOWANCE ****

- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.
- 6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Failure to furnish the sample(s) by the time specified in the Solicitation will require rejection of the Bid.

[] 21. **LABORATORY TEST:** Successful bidder is required to accompany delivery of his goods with a Laboratory Test Report indicating that the product he is furnishing the Government meets with the specifications. This report is on the bidder's account and must be from a certified Testing Association.

1. **BID FORMS:** Each bidder shall be provided with one (1) set of Solicitation forms. Additional copies may be provided upon request. Bidders requesting additional copies of said forms will be charged per page in accordance with 5 GCA § 10203 of the Government Code of Guam. All payments for this purpose shall be by cash, certified check or money order and shall be made payable to the General Services Agency (EO 86-24).
2. **PREPARATIONS OF BIDS:**
 - a) Bidders are required to examine the drawings, specifications, schedule, and all instructions. Failure to do so will be at bidder's risk.
 - b) Each bidder shall furnish the information required by the Solicitation. The bidder shall sign the solicitation and print or type his name on the Schedule. Erasures or other changes must be initiated by the person signing the bid. Bids signed by an agent are to be accompanied by evidence of this authority unless such evidence has been previously furnished to the issuing office.
 - c) Unit price for each unit offered shall be shown and such price shall include packing unless otherwise specified. BACKGROUND

The Department of Parks and Recreation (DPR) currently operates Guam’s only public outdoor recreation pool in the capital city of Hagatna. The Hagatna Pool is a 25 meter x 50 meter (500,000 gal.) pool used primarily for recreational fitness and competitive swimming. The Hagatna Pool facility maintains a male and female bathhouse; kiddie pool; and open recreation space. The pool operates on a sand filtration and chlorine tablet fed filtration system. The general hours of operation for the Hagatna Pool are 6:00 a.m. – 8:00 p.m., Tuesday through Friday, and 10:00 a.m. – 6:00 p.m. on Weekends. The pool is closed on Mondays for general pool maintenance.

The second public outdoor recreational pool is located at the Guam Sports Complex (GSC) grounds in Dededo. The GSC is comprised of the GSC gymnasium, a baseball park (four (4) fields), soccer/football practice fields, outdoor basketball and tennis courts, and a fitness walk trail. The Northern Pool consists of three (3) separate activity areas:

- (1) A zero depth entry for children and individuals with disabilities, with waterslide, squirt guns, fountains and geysers;
- (2) A large spiral water tower to accommodate teens and adults, and
- (3) A 25 yard short course lap and recreation pool.

The Northern Pool has a surface area of 7,525 square feet, holds 189,577 gallons of water, with a turnover rate of 3 hours (1,053 GPM). The depth of the pool ranges from 0’-0” to 7’-3”. In addition the facility has a bathhouse which provides men’s and women’s locker rooms; a concession area; separate management and staff office spaces; mechanical pump room; and pool storage area.

It is DPR’s intent to enter into a comprehensive facilities operations and maintenance contract for the DPR Pools which shall include the operations and maintenance of all pools, pool pumps, filters, and other mechanical equipment required to maintain safe water quality and operational standards, as well as for the building facility and ancillary areas (office, restroom, etc.).

BIDDING ON / REMARKS:

SCOPE OF SERVICES

Pool Contractor Operational Hours: Contractor shall provide for the daily operations and maintenance of the DPR Pools which shall include the operations and maintenance of all pool pumps, filters, and other mechanical equipment required to maintain safe water quality and operational standards from Tuesday through Sunday for the Hagatna Pool (closed on Monday) and Wednesday through Monday for the Northern Pool Complex (closed on Tuesday). Weekday hours of operation are from 6:00 a.m. to 8:00 p.m. and from 10:00 a.m. to 6:00 p.m. on Saturday and Sundays for the Hagatna Pool and 12 Noon to 8:00 p.m. on weekday and 12 noon to 8:00 p.m. on weekends for the Northern Pool. Additional work such as the shocking of pool, painting, pressure washing, etc. may be performed during hours or days when the pools are closed to the public. _____

Transition and Take Over of Operations by Vendor:

Vendor shall ensure that the **DPR POOLS** are ready to open for Public use by completing the following at least fourteen (14) days prior to opening day: _____

Coordinate access to the facility and check out of keys for this preparation work with the Owner designee. Note: the vendor shall bear full responsibility for all keys and/or security access codes/equipment assigned to the vendor and shall be responsible for any alterations to the lock/security system needed, should the system be compromised by the actions of the vendor. _____

Ensure connection of all plumbing fixtures to facility; contact Owner to have water turned on. Note: any cost relative to failure to contact Owner to authorize water to be turned on shall be the Vendor’s responsibility. After water is turned on; monitor all plumbing and report leaks to Owner immediately. _____

SPECIFICATIONS

BIDDING ON / REMARKS:

Inspect, clean, set up and prepare for use all Vacuum/Hoses including appropriate poles; inspect and prepare all garden hoses for use.

Inspect, clean, set up and prepare for use skimmer system including covers and baskets.

Inspect, clean and prepare all drains for use. Ensure covers are secure and all hardware is in place.

Water Lines – adjust valves as needed.

Inspect, clean, set up and prepare for use all skimmer nets, pool brushes, etc.

Inspect and prepare all motors and pumps in accordance to manufacturer’s recommendation to ensure the most effective operation.

Inspect and prepare filter tank for daily operation.
Inspect and prepare for use recirculation feeder.

Ensure proper connection of bathhouse, pool deck, and pump room fixtures. Establish clean seal and ensure no leaks. Turn on water to fixtures.

Clean air jet, fountain, and bubbler caps.

Inspect, set up and prepare all chemicals, feeders, controllers and chemical tubing.

Report to Owner all operating deficiencies and problems at least fourteen (14) days before opening if not immediately.

The Vendor shall provide the Owner a copy of the Vendor’s Procedure manuals And or Standard Operating Procedures for Pool Operations & Maintenance practices fourteen (14) days prior to opening day.

Vendor shall notify the Owner immediately upon completion of cleaning as outlined in this section.

The Owner will also be responsible for the purchase, installation and inspection of pool signage to ensure safe pool operations.

Facilities Maintenance throughout Operating Year:

Vendor shall exercise reasonable care and diligence to provide services for the daily operation and maintenance of the pool complex, which shall include the following duties:

Complete a daily documented, (written) safety check of pool’s mechanical and electrical systems, to include water quality. Form to be pre-approved for site specific features by Owner (14) days prior to opening day. Vendor shall submit completed daily forms to the Owner at the end of each week.

Conduct water testing and maintain records as required by the Department of Public Health and Social Services, Government of Guam and or the Guam Environmental Protection Agency if applicable, and meet all requirements for such reporting.

Maintain any additional records as reasonably required by the Owner to include incident and accident reports (these two report formats will be provided by the Owner).

SPECIFICATIONS:

BIDDING ON / REMARKS:

Maintain and operate the filter equipment in accordance with Department of Public Health and Social Services requirements and manufacturer’s recommendation.

Vacuum pools. Pools shall be vacuumed on a daily basis. All vacuuming shall be performed when the pool is not in use for any activity, program, or public swim time.

Backwash filter system; to be conducted and completed when the pool is not in use for any activity, program or public swim time.

Clean the hair and lint strainers on all pumps and associated filtering devices regularly, daily if necessary. Provide the necessary tools for all equipment Vendor will be operating.

Vendor shall retain a record of all problems brought to their attention. The Owner will review this log at weekly intervals. A daily log of communication shall be kept in the manager's office for the managers and Owner to review on a daily basis.

Duties pertaining to daily opening, closing and operating of this facility shall include:

Ensuring water quality standards are met prior to the opening of the facility.

Ensure all mechanical systems are operable. Clean deck and pool edges as needed

Pressure wash all deck areas (pool deck, entrance & sidewalks) twice yearly (every 6 months).

Painting, scraping & patching:

Vendor shall conduct weekly inspections of the facilities to ensure that all surfaces are free from graffiti and other imperfections in order to maintain the appearance of the facilities. Prepare and paint all deck (including warning and safety signage) and interior and exterior wall surfaces to match within 60 calendar days from the start of each contract year.

Maintenance of All Fixed Recreational Pool and Mechanical Equipment:

Vendor shall ensure that all water slides, water towers, pool access ladders, and Other mechanical systems are inspected bi-annually to ensure that proper torque (in accordance with manufacturer's specification) properly and safe for use. This shall include, but not limited to, all control boards and panels, motors and pumps use in the operation of pools. Vendor must be licensed accordingly to perform this work. This inspection and work shall be included in the Vendor monthly reporting requirement to the Owner.

Locker and Restroom Facilities:

Contractor shall ensure that all locker and restroom facility fixtures (electrical and plumbing) are in operable condition, unless otherwise serviced by separate contract by DPR (Island-wide Restroom Maintenance Contract). Contractor shall be responsible for the repair for all plumbing and electrical repairs required to maintain operability, unless otherwise specified in writing by the Owner. This responsibility extends to paper towel dispensers, liquid soap dispensers, toilet tissue holders, shower heads, faucet fixtures and the like. This requirement excludes owner furnished consumables (paper towel, tissue, soap, trash bags).

Grounds Maintenance and Landscaping:

Contractor shall be responsible for the grounds maintenance and landscaping of all interior and immediate exterior areas of the pools (25 ft. from pool's perimeter fence enclosure). Contractor shall ensure that the green/lawn areas are cut to a minimum height of 1" twice monthly. Hedging and pruning of the landscaped areas shall be performed once monthly.

This responsibility shall include the maintenance of all parking areas (excludes parking and green space surrounding the Guam Sports Complex's walking trail, baseball fields, and surrounding areas and Hagatna Tennis Center and Mass Transit Shelters).

Lighting:

Vendor shall ensure that all existing pool facility lighting are operational (interior, pool, overhead, parking and area lighting). This shall include the cost for replacement fixtures, etc. complete and ready to use.

BIDDING ON/REMARKS:

Preventive Maintenance of HVAC System:

Vendor shall be responsible for the PM service of all existing HVAC systems located at the Northern Pool. PM service shall include weekly filter cleaning and charging of system as required.

Chemicals:

The Vendor shall order, supply and pay for all chemicals, to include the demurrage charges. Prior to opening, the vendor shall provide for chlorine tablets and other chemicals required for PH adjustment of the **DPR POOLS** water. Vendor shall provide all necessary safety equipment for staff for the chemicals used. Any chemicals required for water adjustment other than the normal sanitizing and oxidizing (chlorine) or PH level adjustment shall be the responsibility of the Owner, and the prior, written consent of the Owner shall be obtained by the Vendor before any such additional chemicals are provided or used, for which the Vendor will furnish a water analysis to the Owner when requested.

The Vendor shall test twice daily and record, both in their records and in public view, water quality. Vendor shall be responsible for maintaining the condition of the swimming pool water within tolerance of accepted industry standards. The Vendor shall be responsible for supplying the following chemicals or a combination of chemicals to maintain safe and clean water throughout the contract term at no cost to the Owner:

- Chlorine (tablets)
- Calcium chloride
- Sodium bicarbonate
- Stabilizer
- Soda ash
- Pool acid
- Other Chemicals and or additives as deemed necessary by Contractor in order to maintain water quality which meet or exceed industry standards as well as those water quality standards established by the Department of Public Health and Social Services, Government of Guam.

The following chemicals are currently used by the Owner:

- BIO-GUARD POWERCHLOR (Stabilized Chlorine Shock/Sanitizer (or equal)
- Formula with Filtration Enhance and Clarifier) Size: 35lb./pail
- OMNI CHLORINE 3" Tablet 8oz./Size: 50lb./pail (or equal)
- SANI-T-10 ALGAECIDE Size: 1 gallon (or equal)
- ECR CALCIUM HYPOCHLORITE 1" Briquette Tablets/Size: 55 lb./pail (or equal)

Note: Items listed above are reference brands only

Additional Equipment Provided by Vendor:

As part of the Vendor's operations and maintenance duties and responsibilities, Contractor shall provide, at no expense to the Owner, the following minimum tools and equipment for the maintenance of the DPR Pool Facilities:

- Water Hoses
- Pool Vacuum and Heads
- Pool Poles
- Pool Vacuum Hoses
- Algae Brushes
- Leaf Net
- Torque and calibration equipment
- Water testing equipment and supplies

SPECIFICATIONS:

BIDDING ON/REMARKS:

Additional tools and equipment as deemed necessary.

Inspections:

The **Vendor** shall provide daily Pool inspections at **DPR POOLS**, to be conducted by the **Vendor's** supervisory personnel or designee, and shall report any concerns regarding the **DPR POOL'S** conditions and management to the Owner or its designated representative within 24 hours of inspection.

At the Owner's written request, the **Vendor** shall join Owner for a complete inspection of the Owner's facility. It shall be the responsibility of the **Vendor** to provide the Owner with a detailed specific account of the condition and, long term as well as short-term, needs of the pool. Upon completion, the Contract shall provide a written report sent to Owner within twenty-four (24) hours.

Vendor shall have a certified electrician and mechanical engineer conduct an annual inspection of electrical and mechanical systems prior to the end of each contract year. Written documentation of this inspection shall be provided to the Owner no less than fourteen (14) days prior to the end of the Contract Year.

Maintenance and Replacement of Owner Owned Equipment:

The **Vendor** shall perform minor adjustments and maintenance to the property and facility as part of this maintenance contract, provided that the Owner shall pay for the cost of parts and materials based upon the Owner's prior approval.

Vendor shall be responsible to pay for all minor repair costs (less than \$1,000.). All other repairs and replacement of equipment needed during the Contract Year to continue the operation of the **DPR POOLS** and to maintain health and safety standards shall also be performed by the **Vendor**, at the Owner's discretion and at the Owner's expense; provided that the **Vendor** shall advise and receive written approval from the Owner of the cost of major (exceeding \$1000.) repairs prior to the performance of such repairs. For major repair work, Owner shall pay the repair amount over \$1,000.

Vendor shall be responsible for the first \$1,000. of repair costs. The **Vendor** shall act as consultant and advisor to the Owner in the event of needed repairs to the **DPR POOLS** facility.

The **Vendor** shall provide to the Owner a reasonably detailed estimate for the repair. All repairs needed to render the **DPR POOLS** in operational condition will be made by the **Vendor** at the Owner's expense, except to the extent such repairs are result of the negligence or willful misconduct of the **Vendor**, its employees, agents or subcontractors. It is understood and agreed that this covenant is an independent covenant of this Agreement notwithstanding any alleged breach of any other covenant.

The **Vendor** shall be responsible for the care and repair of Owner property used for the operation of the **DPR POOLS**. Any said property shall be returned to the Owner at the end of the Contract Term in the same condition as received, reasonable wear and tear expected.

The **Vendor** shall be held accountable for those losses and damages to buildings and Owners property due to theft or abuse during the normal hours of operation of the **DPR POOLS** complex. The **Vendor** shall try to prevent losses and damages to Owner owned property during hours of operation, and shall ensure that the facility is properly locked and secured upon every closing day.

Damaged or malfunctioning equipment should be reported immediately to the Owner. **Vendor** shall submit follow-up written documentation to Owner within twenty-four (24) hours. If not reported, **Vendor** will be responsible for damages. The **Vendor** shall not be liable for damages to **DPR POOLS** caused by faulty construction.

Repair Bills and Invoices: Subject to the terms of this Section, the Owner will pay all reasonable repair bills and invoices submitted to the Owner by the **Vendor** for repair materials and services necessary and actually provided for the **DPR POOLS** within forty-five (45) days from the date of receipt of the invoice.

Certification:

Vendor shall have all applicable and required Guam Contractors License Board and Guam Business Licenses. In addition, vendor shall staff a Certified Pool Operator (CPO) to oversee the operations of the management and maintenance of the pools. The CPO shall be certified by the National Swimming Pool Foundation or equivalent recognized certifying body in the U.S.A. The vendor's CPO credentials must be presented to DPR prior to the opening date of the pools and shall be maintained by vendor for the duration of the contract term.

Training Requirements:

Vendor shall be responsible for all training of its employees necessary to operate the *DPR POOLS* in compliance with this bid and to all applicable local and federal laws. This training shall include, but not be limited to:

- a. Proper certifications and qualifications as required by Owner. All requirements shall be satisfactory to Owner prior to Vendor's work on site.
- b. Owner orientation training and facility specific training.
- c. Blood Borne Pathogens as required by policy approved by Owner and OSHA.
- d. Independent Mechanical Operation of Pool.
- e. Vomit and Fecal Matter per policy approval by Owner.

Duties of Operations and Maintenance Supervisor:

Vendor, if selected, must provide to the Owner a copy of their Employee Manual, outlining the expected duties and responsibilities of the Operations and Maintenance Supervisor, Pool Operator, CPO and other positions required for the required maintenance and operation of the DPR Pools fourteen (14) days prior to start of contact.

Owner Responsibilities: Access, Equipment and Utilities:

Owner shall provide at no cost to the vendor the following:

- Utilities
- Trash Receptacles
- Telephones
- Balance of chemicals listed in Item 4 above.

The Owner agrees to communicate any comments, suggestions or complaints concerning the *DPR POOLS*, pool staff, or management service, directly to the vendor or his designee.

Minimum Safety Standards:

Owner acknowledges the duty to operate the *DPR POOLS* within the established local health department regulations and minimum safety standards. Owner will comply with minimum standards in the following areas:

- a. Safety warning signs on pool depth;
- b. Tile depth markings at water line and on pool deck;
- c. Safety equipment shall be provided to include ring buoys, rescue tubes, shepherd hooks, first aid kit, and safety rope with buoys;
- d. G.F.I. circuit breakers for underwater pool lights.

The Owner reserves the right to store equipment to be used for aquatic activities in the *DPR POOLS* facility; the vendor shall exercise the same level of protection for said equipment as for all other Owner property.

Emergency Closing Of DPR POOLS: The Owner and/or Vendor may close the *DPR POOLS* in an emergency situation, whether the emergency is caused by a breakdown of equipment or by other cause outside of the Vendor's control. The party, which has determined to close the *DPR POOLS*, shall immediately inform the other of the emergency closing. If the closing of the *DPR POOLS* exceeds one (1) hour in duration, then the extended closure of the *DPR POOLS* shall be subject to approval by the Owner. Emergency closing of the *DPR POOLS* shall not require any change or adjustment in any of the provisions of this Agreement, unless the closing exceeds one (1) day in duration.

For those closings of the *DPR POOLS* which result from causes within the control of the Vendor and/or for which the Vendor is negligent and for which more than one (1) day is necessary to perform repairs and/or restore *DPR POOLS* to normal operation, and if the Vendor or any other Vendor is performing the repairs, the Vendor shall pay to the Owner upon demand two hundred dollars (\$200) per day until such time as the *DPR POOLS* is reopened for normal operation. The Owner, at its option, may deduct any such amounts against any payments due or becoming due to the Vendor.

The Vendor shall have the authority to close the **DPR POOLS** during inclement weather (heavy rain, high wind, lightning, or thunder) and shall be prepared to reopen when the weather permits. The Contractor shall adhere to a thirty-minute closing time for lightning and thunder. The pool will remain closed for heavy rain until pool bottom can be seen. The pool will remain closed until high winds subside to where it is safe for both staff and patrons to reenter. The **DPR POOLS** will be closed down upon Government of Guam declaration of Condition of Readiness 2 and re-open upon declaration of Condition of Readiness 4.

The Vendor shall have the personnel available seven (7) days per week, twenty-four (24) hours per day to check the pool if damage is possible due to weather related events or has occurred due to vandalism or other known event and to attend to any problems that may arise as well as, the Vendor shall take any appropriate actions to prevent and minimize any such damages from occurring.

Office Space provide to Vendor:

Owner shall provide one (1) office space within the Northern Pool for use by the Vendor and Vendor employees. The use of this office space shall be directly related to the facilities management, operation and maintenance of the pools. Vendor shall be prohibited from utilizing subject office space outside of the normal operating hours required to perform this contract.

Statement of Qualifications and Experience:

Vendor must provide verifiable documentation substantiating that the vendor has a minimum of five (5) years of comprehensive pool maintenance experience. This item must be included in the vendor's Statement of Qualification in the bid documents.
