Question 1:

On Page 33, under specifications, $5\ 1/2\ x\ 8\ 1/2\ to\ 12\ x\ 19$; There are 4 commonly used paper size: Letter 8.5 x 11, Legal 8.5 x 14, Executive 7 x 10 & Ledger/Tabloid 11 x 17. Most copy machines have max paper size of 11 x 17, SBS Guam requests changing max paper size from 12 x 19 to 11 x 17 or 12 x 18 in order to make other brand/models available for consideration in response to this bid.

Response: The specification on page 33 will remain status quo. (No change to paper size)

On Page 33, under specifications, 250 Sheet automatic single pass document feeder; SBS Guam kindly requests to adjust 250 sheets to 240 sheets in order to make other brand/models available for consideration I n response to bid.

Question 3:

On Page 33, under specifications, Two-Sided printing and copying up to 12×19 ; There are 4 commonly used paper size: Letter 8.5 x 11, Legal 8.5 x 14, Executive 7 x 10 & Ledger/Tabloid 11 x 17. Most copy machines have max paper size of 11 x 17, SBS Guam requests changing max paper size from 12 x 19 to 11 x 17 or 12 x 18 in order to make other brand/models available for consideration in response to this bid. Can the specifications be adjusted to encourage other companies' products to participate in the bid?

Response: The specification on page 33 will remain status quo.

Question 4:

On Page 33, under specifications, Print Resolution 1200 x 2400 dpi;

SBS Guam kindly requests to adjust the required print resolution to 1200 x 1200 dpi. On inkjet printers you can see that the resolution is clearly different, however it is difficult or impossible to detect the difference in print quality between 1200 x 1200 dpi and 1200 x 2400 dpi products in laser printers. This is because the size of the ink droplets sprayed by the inkjet can be adjusted but the toner powder of the laser is already formed. There is a limit to the detailed expression with large toner particles.

Question 5:

On Page 33, specifications, Black and Color Scanning Speed range up to 270 images per minute (ipm): SBS Guam kindly request scan speed to be adjusted from 270 ipm to 240 ipm in order to make other brand/models available for consideration for bid.
