Clarification on "Amendment #5" change of "UOM"

#### Question 1:

After reviewing the unit of measures of the items on the amended item lists, it's more confusing on the unit of measure. For example: Item Line 1.1, 2.1, and 3.1 – the description stated the number of OZ/can. You are asking the quantity with UOM by OZ (Ounce). The vendors sell's the item by the cans not by the ounce (OZ). Follows the other line items number listed below clarifying the UOM – Unit of Measure:

- 5.1: Asking for 1240ml/bag – UOM is OZ. Vendor sells by the bag
- 6.1, and 9.1: Asking for 1 Gallon – UOM is OZ. Vendor sells by the gallon
- 8.1: Asking for 24oz/btl - UOM is OZ. Vendor sells by the bottle
- 10.1: Asking for 32oz/btl – UOM is OZ. Vendor sells by the bottle
- 12.1: Asking for 40oz/btl – UOM is OZ. Vendor sells by the bottle
- 14.1 and 21.1: Asking for 15oz/can – UOM is OZ. Vendor sells by the can
- 27.1: Asking for 21oz/can – UOM is OZ. Vendor sells by the can
- 28.1: Asking for 5.75oz/btl – UOM is OZ. Vendor sells by the btl or case
- 31.1: Asking for 32oz/btl – UOM is OZ. Vendor sells by the bottle
- 32.1: Asking for 8oz/btl – UOM is OZ. Vendor sells by the bottle
- 33.1: Asking for 0.85oz/tube – UOM is OZ. Vendor sells by the tube
