Scope of Work

Intake Building

- 1. Replace camera on second floor above office worker's desk on the drop ceiling.
- 2. Replace cameras on 1st floor near YSS desk and break room.
- 3. Replace outdoor cameras near security window and facing the courtyard.
- 4. Remove old G4S DVR and G4S Acer computer recording systems in Superintendent's office and consolidate all camerasinto the brand new camera server.
 - a. The original G4S POE switch and TV monitor will be reused.
- 5. Label cables to correspond to connected camera and switches.
- 6. Replace cable routed through the 1st floor and 2nd floor of Intake/Bldg. H into the Superintendent's Office.
- 7. Setup the computer on the first floor to allow viewing of surveillance cameras.

Delta Unit

- 1. Replace junction LB covers outside the door to Delta Unit.
 - a. Use the replacement LB covers for the LB junctions for the cable.
 - b. Reattach the loose LB junction to the EMT pipe going in and out of the building in front of the door.
- 2. Replace cable going from Delta Unit to Intake Building.
- 3. Replace camera above control room.

LF2 Unit

- 1. Replace one camera in the counselor's office.
- 2. Replace camera in LF2's conference room.
- 3. Replace cable going from LF2 to Delta.

Foxtrot Unit

- 1. Install cameras in the Control room, Hallway in CJC, Hallway in general population.
 - a. When remounting the cameras ensure that the cable connector is sealed with a weatherproof seal as the conduits for the lines and the mounting boxes are right beneath the airducts which generates moisture and water.
- 2. Replace and install camera above north entrance/exit door of dayroom.
 - a. When remounting the cameras ensure that the cable connector is sealed with a weatherproof seal as the conduits for the lines and the mounting boxes are right beneath the airducts which generates moisture and water.
- 3. Replace cable from camera pole north of Foxtrot unit, through Foxtrot and to the gym. Route this cable to Intake building.
- 4. Replace and route the cable from the PTZ near gym to the Intake Building.

Echo Unit

- 1. Replace cameras in the north wing hallway, north wing dayroom, south wing hallway, and south wing dayroom.
- 2. Replace and route cable in Echo unit to Intake.

Liheng Famagu'on (LF)

- 1. Replace cameras in the 3 classrooms.
- 2. Replace and route cable in LF to Intake.

Perimeter

- 1. Install PTZ camera on pole mount near the gym.
 - Seal junction boxes for the PTZ cable and ensure that the cable will no longer be exposed to the elements.
 - b. Replace and route the cable from the PTZ near gym to the Intake Building.
- 2. Replace and route cable from DYA main gate camera to Intake.
 - Seal junction boxes for the camera cable and ensure that the cable will no longer be exposed to the elements.
- 3. Replace and route cable from Gate 2 PTZ camera (this camera is located in the parking lot; near the outdoor basketball court) to Intake.
 - a. Seal junction boxes for the PTZ cable and ensure that the cable will no longer be exposed to the elements.
- Replace and route cable from the PTZ camera, near the north fence line (to the northwest of Echo unit), to Echo unit and then to Intake Building.
 - a. Seal junction boxes for the PTZ cable and ensure that the cable will no longer be exposed to the elements.

Director's Office

1. Setup remote viewing of surveillance system at Director's office.
